Each session will run approximately **75 minutes**. When the schedule allows, participants are welcome to stay online for questions.

We are willing to offer sessions at different times, provided enough participants register. Email the CRISS office: info@projectcriss.com to request other times.

Project CRISS is currently using Adobe Connect Pro for our meeting space. Participants will need a fast internet connection (not dial-up), the latest version of Adobe Flash, microphone headset or a phone. Participants CAN participate via chat if audio is not an option.

Each session will walk through the changes to the Level I training. We will take questions as time allows, and we will schedule Q & A online meetings and provide a FAQ sheet to address questions that come up once participants have time to review all of the session materials.

CRISS staff will contact each participant with meeting connection information prior to the session. Some materials will be provided ahead of time (e.g. new text passages). 4th edition manuals will be shipped for arrival prior to the start date. Scripts and slides will be provided at the conclusion of each session.

Participants will need to read Chapter 1: Teaching for Understanding prior to attending Session I.

ONLINE UPDATE SESSION DESCRIPTIONS

ONLINE SESSION (complete series, I-V; participant trains w/ 4th ed. manual and revised Level I)

Trainers who opt to complete the entire series use the registration form to pay, then schedule the individual sessions by calling the CRISS office or emailing info@projectcriss.com. Each scheduled session is limited to 25 participants. Trainers must complete the entire session to receive credit and access to the complete set of training materials. A 4th edition CRISS manual is included in this registration fee. Trainers must complete the series in order to use the manual and the revised Level I materials. The training series must be completed no later than July 31, 2012.

ONLINE SESSION I ONLY (participant trains w/ 4th ed. manual, revised Introduction, and 3rd ed. learning plans and mini-lessons)

Trainers who opt to complete only Session I online use this form to pay, and then schedule attendance by calling the CRISS office or emailing info@projectcriss.com. The session is limited to 25 participants. Trainers must complete the entire session to receive credit and access to the training materials. A 4th edition manual is included in this registration fee. Trainers may use the 4th edition manual, the revised Introduction, and the 3rd edition learning plans and mini-lessons. Trainers may NOT pursue National Trainer certification and do not have access to the revised learning plans and materials. Attendees at sessions with this trainer who later seek trainer certification themselves will need to attend at least one revised (all 4th edition materials) Level I prior to attending a Level II workshop. Trainers may NOT co-train with another trainer using the 4th edition revised Level I materials. This training is intended for individual District Trainers who are the only trainers within their district, will not be training teachers from another district, and will not be pursuing National Trainer certification. In the event that a trainer chooses this option in 2011-2012, but decides to upgrade certification to include all of the 4th edition revised materials, s/he may complete the series for the full cost (\$175).
