## UPDATE SESSION DESCRIPTIONS

### **ONLINE SESSION (complete series, I-V; participant trains w/ 4<sup>th</sup> ed. manual and revised Level I materials)**

Trainers who opt to complete the entire series use this form to pay, and then schedule the individual sessions by calling the CRISS office or emailing info@projectcriss.com. **Trainers must attend Session I first**; the other sessions may be taken out of order if necessary. Each scheduled session is limited to 25 participants. Trainers must complete the entire session to receive credit and access to the complete set of training materials. A 4<sup>th</sup> edition CRISS manual is included in this registration fee. Trainers must complete the series in order to use the manual and the revised Level I materials. The training series must be completed no later than July 31, 2012.

**Note:** **National and Master Trainers** must participate in the complete series and/or an in-person session **AND** use the updated 4<sup>th</sup> edition training materials when they facilitate Level I trainings.

**ONLINE SESSION I ONLY (participant trains w/ 4<sup>th</sup> ed. manual, revised Introduction, and 3<sup>rd</sup> ed. learning plans and mini-lessons)** Trainers who opt to complete only Session I online use this form to pay, and then schedule attendance by calling the CRISS office or emailing info@projectcriss.com. The session is limited to 25 participants. Trainers must complete the entire session to receive credit and access to the updated 3<sup>rd</sup> ed training materials (PPT and Materials packet). A 4<sup>th</sup> edition manual is included in this registration fee. Trainers may use the 4<sup>th</sup> edition manual, the revised Introduction, and the updated 3<sup>rd</sup> edition learning plans and mini-lessons. Trainers may NOT pursue National Trainer certification and do not have access to the revised 4<sup>th</sup> ed learning plans and materials. Attendees at sessions with this trainer who later seek trainer certification themselves will need to attend at least one revised (all 4<sup>th</sup> edition materials) Level I prior to attending a Level II workshop. Trainers who have participated only in Session I may NOT co-train with another trainer using the 4<sup>th</sup> edition revised Level I materials. This training is intended for individual District Trainers who are the only trainers within their district, will not be training teachers from another district, and will not be pursuing National Trainer certification. In the event that a trainer chooses this option in 2011-2012, but decides to upgrade certification to include all of the 4<sup>th</sup> edition revised materials, s/he may complete the series for the full cost (\$175).

### **IN-PERSON SESSION (complete update; participant trains w/ 4<sup>th</sup> ed. manual and revised Level I materials)**

Trainers who opt to complete the in-person session use this form to pay and register for the training location. Each session requires a minimum of 20 and a maximum of 50 participants. Trainers must complete the entire session to receive credit and the complete set of training materials. A 4<sup>th</sup> edition manual is included in this registration fee. Trainers completing this session may use the 4<sup>th</sup> edition manual and all of the 4<sup>th</sup> edition Level I training materials (National & Master Trainers, and those who co-train with other trainers or with participants from multiple districts are required to use the new materials). Registrants who, for any reason must cancel their attendance at an in-person session may update via online sessions or a different session (space permitting). No refunds will be issued.
